EMPLOYEES COMPULSORY/VOLUNTARY RETIREMENT REGULATION-1984

- 1. <u>Title and Commencement</u>: (1) These Regulations may be called "The Karnataka State Road Transport Corporation Employees Compulsory/Voluntary Retirement Regulation, 1984".
- 2. They shall come into force on such date as the Corporation may appoint by publication of a notice, specifying the date on the notice board of the Central Office of the Corporation at Bangalore.
 - a). <u>Definitions:-</u> In these regulation unless the context otherwise requires. "Corporation" means the Karnataka State Road Transport Corporation.
 - b). "Competent Authority" in relation to exercise of any power under these regulations is the appointing authority as defined under Sub-Regulation (2) of Regulation 2 of the KSRTC (Cadre and Recruitment) Regulation, 1982.
 - c). "EMPLOYEE" means an employee of the Corporation whose conditions of appointment and service can be determined by the corporation by Regulations made under Section -45 of the Road Transport Corporation Act 1950.
 - d). "Service" means service rendered in both substantive and officiating posts.
 - e). Words and expressions used in these Regulations and not herein defined but defined in other Regulations made by the Corporation under Section 45 of the Road Transport Corporations Act 1950 shall have respectively the meaning assigned to them in these Regulation.
- 3. <u>Application:</u> These Regulations shall apply to all the employees of the Corporation.
 - 4. <u>Compulsory/Voluntary Retirement:</u>
- 1) An employees may voluntarily retire from services who has been certified to be Medically incapacitated to discharge the duties of his post due to bodily or mental infirmity irrespective of age or service. Provided further, an employee who gas attained the age of 55 years may retire Voluntarily without production of Medical Certificate.

2) The Competent Authority, may order compulsory retirement of an employee from service of the Corporation who has been certified to be medical incapacitated to discharge the duties of his office/post due to bodily or mental infirmity irrespective of age or service.

5. Authority to issue Medical Certificate:

In case of bodily injuries medical certificate shall be granted by the Medical Officer of the KSRTC. In case an employee suffering from mental disease a certificate shall be granted by the Superintendent. All India Institute of Mental Health and Neuro Sciences, Bangalore. In case of diseases of the eye, Medical Certificate shall be granted by an eye specialist of Government Hospital not below the rank of Surgeon.

Note:- In cases, where the Medical Certificate produced are doubtful or not specific, then the Competent Authority may direct an employee to Produce a certificate issued by the Medical Board.

6. <u>Payment of Accumulations in case of Compulsory/Voluntary</u> Retirement.

Where an employee ordered to be retired compulsorily or an employee retired voluntarily he shall be eligible to receive in full the accumulated Provident Fund, Proportionate Gratuity if any eligible under the relevant Rules/ Regulations and encashment of accumulated leave as is applicable to employee retiring in the normal course, subject to such limits and conditions as prescribed in this behalf.

7. <u>Power to issue subsidiary orders:</u>

The Corporation or the authority authorized by the Corporation may issue such order not inconsistent with the provisions of these regulations, as it may deem necessary to give effect to the provisions of these regulations.

8. <u>Interpretation:</u>-

If any question arises relating to interpretation of any of these regulations, it shall be referred to the corporation whose decision thereon shall be final.
